Subject: Selection list for the post of Lab Assistant, Item No. 260, Division Cadre Jammu, Health and Medical Education Department advertised vide Notification No. 05 of 2015 dated 01.09.2015 – Cancellation of withheld recommendation thereof.

Whereas, the J&K Services Selection Board (JKSSB), vide Notification No. 03-Selection of 2025 dated 28th of February, 2025, issued under endorsement No. JKSSB-Scry/21/2024-03 (E-7623443), notified the Final Selection List for the Lab Assistant, Item No. 260, Division Cadre Jammu, Health and Medical Education Department advertised vide Notification No. 05 of 2015 dated 01.09.2015 and forwarded the recommendation of the selected candidates to the Health and Medical Education Department vide communication No. JKSSB-Scry/21/2024-03 dated 28.02.2025; and

Whereas, among the selectees, the recommendation of candidates namely Ms. Nageen Begum, D/o Parvez Ahmed, R/o Bahsohli, Kathua, figuring at Sr. No. 09/OM category, Roll No. 12050005774 and Ms. Savi Dutta, D/o Sudesh Kumar Dutta, R/o Rajouri, figuring at Sr. No. 32/OM category, Roll No. 12150005872 were kept withheld subject to production of bonafide certificate of diploma and recognition status of institute issuing Degree and relevance and subject to clarification with regard to dual/ overlapping of 10+2 & diploma in MLT respectively; and

Whereas, the J&K Services Selection Board served a notice dated 14.02.2025 to the above-mentioned candidates to submit the pending/requisite documents/certificates as indicated against their names; and



Whereas, this was followed by Final Notice issued vide No. JKSSB-Scry/21/2024-03 (E-7623443), dated 11.08.2025 advising the above mentioned candidates to submit the requisite document within a period of 05 days; and

Whereas, the mentioned candidates failed to produce the requisite certificates and accordingly the withheld recommendation cases were placed in the 320th Board Meeting, which taking note of the fact that despite sufficient time/opportunities afforded to the candidates namely Ms. Nageen Begum and Ms. Savi Dutta, the candidates have failed to produce the requisite certificate/clarification and, accordingly decided to cancel their withheld recommendation.

Now, therefore the withheld recommendation of the candidates namely Ms. Nageen Begum, D/o Parvez Ahmed, R/o Bahsohli, Kathua, figuring at Sr. No. 09/OM category, Roll No. 12050005774 and Ms. Savi Dutta, D/o Sudesh Kumar Dutta, R/o Rajouri, figuring at Sr. No. 32/OM category, Roll No. 12150005872 for the post of Lab Assistant, Item No. 260, Division Cadre Jammu, Health and Medical Education Department advertised vide Notification No. 05 of 2015 dated 01.09.2015, are hereby cancelled.
