- **Note:** 1). Only the shortlisted (wherever applicable) eligible candidates to be called for interview and the call letters to be sent to their respective registered emails furnished in the application form.
 - 2). All the Provisionally eligible Candidates for the post of Assistant Professor (OBC) are required to submit the latest Proper Central Government format of OBC certificate along with Ph.D MSP certificate.
 - 3). The eligible candidates shall be shortlisted for the interview on the basis of merit as per the ratio of 1:20 (01post: 20 candidates) followed by 1:10.
 - 4). Research Papers Published in Journals reflected in International Databases (SCI/AICTE/UGC/Scopus and Web of Science) have been considered.
 - 5). No correspondence/e-mails shall be sent to the candidates under in-eligible list. They have to refer to the list furnished below to know the reasons for rejection.
 - 6). In case of any grievance, the candidates can submit the same by or before 12th December, 2025 (up to 5:00pm) after which no claim/grievance shall be entertained. The aggrieved candidates can submit the documents in support of their claim in person at Recruitment Section, Tulmulla Campus, Ganderbal or via email at jobs@cukashmir.ac.in.
