**Subject:** Final Selection List for 306 posts of Junior Assistant, Advertisement Notification No's 04 & 05 of 2021 and 02 & 04 of 2022-Cancellation of withheld recommendations thereof.

Whereas, the J&K Services Selection Board (JKSSB), vide Notification No. JKSSB-Scry/2/2025-06 (E-7628025) dated 21.04.2025, notified the Final Selection List for the posts of Junior Assistant, UT/ Divisional/District Cadres, Jammu/Kashmir, under various Item Nos, advertised vide Advertisement Notification Nos. 04 & 05 of 2021 and 02 & 04 of 2022 and forwarded the recommendation of the selected candidates to the Indenting Departments.

Whereas, among others, the recommendation in respect of below mentioned **02 candidates** was kept withheld on account of various deficiencies, with the advice to submit the requisite documents/certificates within a period of 15 days and the candidates failed to produce the requisite documents within the stipulated timeline:

Whereas, the withheld recommendation cases of the aforementioned candidates were placed in the **306<sup>th</sup>** Board Meeting, in which the Board decided that a **Final Notice** through speed post/ registered post be served to both of them and thereafter cancel their withheld recommendation if no response is received.

Accordingly, a Final Notice dated 15-07-2025 was served to the above mentioned two candidates through speed post to submit the requisite documents



within a period of 07 days from the issuance of the said Notice. However, no satisfactory response was received from Ms Palvi Sharma and Mr Prashant Sharma. The matter was subsequently again placed before the Board in its 331st meeting in which the Board decided to cancel the withheld recommendation of both the candidates.

Now, therefore the withheld recommendation(s) of two candidates namely **Mr. Prashant Sharma S/o Tara Chand, R/o Seen Thakran, Udhampur-182121 figuring at Sr. No. 02/OM category** under **Item No. 093**, advertisement notification No. 02 of 2022 dated 09.02.2022 and **Ms. Palvi Sharma, D/o Pardeep Kumar R/o Siot Rajouri-185152, figuring at Sr. No. 1/EWS category**, under **Item No. 034**, advertisement notification No. 02 of 2022 dated 09.02.2022, **are hereby cancelled.**
