Audio Visual Mechanic	03 years diploma with not less than 65% marks in Electronics & Communication from a recognized Institute/Board.
Kitabat Instructor	Matric having passed with 2 years Urdu Calligraphy examination from a recognized Institution/Board with 5 years practical experience.
Junior Engineer	Degree in Electrical/Mechanical/ Civil/Computer/Electronics and Communication from any recognized University with minimum 50% marks.

Whereas, the J&K Services Selection Board, accordingly, conducted an (OMR) based written examination for these posts on 16.02.2025, 02.03.2025, 09.03.2025 and 18.03.2025 and accordingly the result was declared on 24.04.2025, 14.05.2025, 20.05.2025 and 27.05.2025.
