Notification

Whereas, the Social Welfare Department, vide Indent No. SWD-ESTB/53/2021-01 dated: 23.03.2023 and SWD-ESTB/53/2021-01 dated 25.05.2023, forwarded the requisition for making direct recruitment to the 201 posts of **"Supervisor"**, which were advertised by JKSSB vide Advertisement Notification No. 02 of 2023 dated 08.12.2023 under various Item nos. 08 to 26; and

Whereas, the Jammu and Kashmir Services Selection Board (JKSSB) advertised the 201 posts of Social Welfare Department vide Advertisement Notification No. **02 of 2023 dated 08.12.2023;** and

Whereas, the Social Welfare Department conveyed change in the available posts in respect of various categories/cadres already advertised and against 201 posts so advertised, the department revised the number of posts to 186, which was notified vide Notice No. JKSSB-PLAN/1/2023-03(E-7098040) dated 14.05.2024, for the information of the candidates. Whereas, as per the Indent/Advertisement, the qualification prescribed for the posts is/was as follows:

"Female Graduate. Preference shall be given to candidates having Home Science, Child Development/ Sociology as one of subject."

Whereas, the select list for the aforementioned posts was forwarded to the Social Welfare Department vide JKSSB communication No. JKSSB-Scry/5/2024-03(E-7642007) dated 24.02.2025; and

Whereas, the wait list in the instant selection was not forwarded along with the select list, as Regulation 68 of the Jammu and Kashmir Service Selection Board (Business and Procedure) Regulations, 2022 provided that in respect of the Combined Selections, the Board has to maintain a category-wise Combined Waiting List with it and forward the same to the Indenting Department as and when requested by it; and

Whereas, the Social Welfare Department vide communication vide No. SWD-ICD/35/2025(7672285) dated 25.09.2025 requisitioned a wait list of 13 posts, due to the vacancies, accrued either due to non-submission of joining reports after issuance of the appointment orders or non-submission of PVRs within a period of 21 days or due to no contact or response to the notice issued by the concerned HoDs in pursuance of the instructions as contained in Govt. Order No.528-JK (GAD) of 2021 dated 27.09.2021, detailed as under:

It is further notified that:

- (i) The Wait List shall be subject to the outcome of writ petition(s), if any, pending in any Court of Law of the competent jurisdiction.
- (ii) The Wait List shall also be subject to the outcome of pending inquiry, if any, involving candidate(s), figuring in this Selection List.
- (iii) The formal recommendation to concerned Indenting Department shall be forwarded separately.
- (iv) The candidate(s) whose recommendations are kept withheld shall submit the requisite documents/certificates within a period of one month.
- (v) The Selection of the candidates has been made on the basis of Self-declarations/Certificates submitted by them and if at any stage, it comes to the light that any candidate(s) has submitted false information or has secured

selection in the list on the basis of fake documents/certificates, the selection shall be liable to cancellation at any stage.
