Terms & Conditions:

- ✓ The candidate(s) who fail to produce any certificate / testimonial(s) in original before the Document Verification Committee at the time of Document Verification shall forfeit their candidature.
- ✓ The candidate(s) who fail to appear in-person, for verification of documents & ascertaining of eligibility on the above date shall not be called later and shall forfeit the right for consideration.
- ✓ In case any deficiency with reference to eligibility, etc is established/proved at the time of Document Verification or subsequently, the candidate shall not be considered for selection and will be treated as disqualified *ab-intio*.
- ✓ Any candidate found guilty of impersonating or submitting fabricated/tampered documents/testimonials or making false, incorrect or suppressing material information shall be liable for criminal prosecution under law and shall be debarred

from all the future exams of the University. Also canvassing/lobbying in any form will entail disqualification of the candidate.
