

**"Graduation in any discipline from a recognized University with PGDCA from any recognized institute/University or Bachelor of Computer Application (BCA) or Bachelor of Computer Science/IT or Bachelor Degree including BE/B.Tech in Computer Science/IT or any other equivalent degree in relevant field of Computer Applications/Computer Science".**
