- a. I understand all the terms and conditions set out in the agreement (Form A of S.O 364 of 2020) and I shall be bound by all such terms and conditions (Form A of S.O 364) duly executed by me.
 - b. If any of the information furnished by me to the college is found wrong at any point of time, I shall be liable to be punished under rules including confiscation of the Registration of the Doctor.
 - c. I will not participate in any kind of strike during the period of my tenure engagement. In the event I proceeded on strike, my tenure engagement shall be terminated without any notice as this service is covered under ESMA Act.
 - d. I shall remain disciplined during the tenure period; any kind of misconduct shall make me liable for termination without any prior notice.
 - e. I am not involved in any criminal activity nor is there is any FIR/Court case pending/registered against me in any criminal department or police station/Hon'ble Court.
 - f. My engagement is strictly provisional till the recipient of verification of documents/ testimonials and verification report for character and antecedents from CID.  4. The Senior Residents (Non-PSC) appointed on Academic Arrangement Basis shall be paid as per S.O 364 of 2020 dated 27-11-2020. However, In-service (PSC confirmed) candidates shall be paid salary as per their LPC. The PSC confirmed appointees are required to furnish the NOC from Director Health Services concerned before their joining, failing which they will not be allowed to join and their selection will be cancelled.
 5. The salary of the appointed candidate(s) shall be drawn/disbursed only after recipient satisfactory report of verification of character & antecedents and documents/ testimonials from the concerned quarters.
