D. Selection Procedure

The mode of selection shall be as follows:

Section Officer	Written Examination: The selection for the post shall be made on the basis of merit obtained in written examination (100 marks) which will be reduced to 80 marks provided the candidate has qualified the mandatory skill test. Interview: Interview shall be conducted which shall consist of 20 marks.
2.	Personal Assistant (P.A.)	The selection for the post shall be made on the basis of merit obtained in written examination (100 marks) which will be reduced to 80 marks provided the candidate has qualified the mandatory skill test. Interview: Interview shall be conducted which shall consist of 20 marks.

Note:


- a. The candidates are required to obtain 50% marks in the written examination to qualify for the skill test.
- b. For skill test, the University shall call candidates in the ratio of 1:30 out of which 20 candidates will be shortlisted for interview on the basis of merit.


E. General Terms and Conditions:

1. Candidates are required to apply online through online recruitment portal of the university website: <https://cusrinagar.edu.in>. No other means/mode of application will be accepted.
2. All the relevant information/updates shall be uploaded on the University website from time to time. The candidates are advised to remain in touch with the University website <http://www.cusrinagar.edu.in>. To notify the same in newspapers shall not be obligatory on the University.
3. The applicants shall carefully fill the details in the online application form and the information /details so submitted shall be treated as final for the purpose of determining eligibility of the candidate and no claim, whatsoever, on this account, shall be entertained subsequently.
4. The intending eligible candidates, who wish to apply for more than one post, must submit separate Application Forms along with the prescribed fee for each post.
5. Before applying for a post, candidates are advised to satisfy themselves about their eligibility.
6. It is the responsibility of the applicant to assess his/her own eligibility to the post(s) for which he/she is applying in accordance with the Advertisement. If, at any stage, it is found that the applicant is not eligible as per the prescribed eligibility criteria, which could not be detected at the time of selection for whatever reason; his/her candidature / appointment shall be liable to be cancelled / terminated immediately.
7. Application form found incomplete at any stage in any respect shall be rejected without any Notice;
8. Applications received without the prescribed fee shall not be considered and summarily rejected. No representation against such rejection will be entertained. Fee once paid shall not be refunded under any circumstances not will it be adjusted against any other examination or selection.
9. The number of posts shown above may vary during the recruitment process. The university reserves the right not to fill any/ all posts advertised and to reject any/all application without assigning any reasons thereof.
10. The appointment to the notified positions is provisional and subject to the verification of documents/claims through proper channels. If the verification at any point of time reveals that the claim of the candidate/s belonging to a particular category is false, his/her services will be terminated forthwith without assigning any further reason(s) and without prejudice to such further action as may be taken under the provisions in Bharatiya Nyaya Sanhita for production of false certificates;
11. The eligibility of candidates will be determined as on the last date fixed for submission of online application forms;
12. Candidates who have successfully submitted their online application form have to ensure that their name appears in the list which would be available on the University website in due course of time.
13. Impersonation or submission of false/fabricated/tampered documents or making incorrect/false statements by the candidate will, in addition to debarring him/her

- permanently or for a specific period from any employment in the University and also liable for criminal prosecution;
14. No disciplinary/ vigilance case should be pending against the applicants working in any Govt./ Semi- Govt./ Autonomous Organizations. The applicants are advised to submit correct information in the application form.
 15. Age of superannuation shall be as per the Jammu & Kashmir University Norms;
 16. Cluster University of Srinagar will not be responsible for loss of any communication due to wrong address provided by the candidate or unsuccessful transaction through Payment Gateway etc.
 17. The shortlisted applicants are required to produce printout of ONLINE application form (Hardcopy) completed and duly self-attested along with supporting documents (Original and one set of self-attested copies) for the document verification as and when notified by the university;
 18. Candidates called for document verification shall have to produce the original documents relating to their age, educational qualifications, experience and fitness etc. before the Verification Committee;
 19. Mere appearance in the written examination/Skill Test/Interview does not automatically entitle a candidate to be considered for appointment.
 20. A candidate seeking his/her consideration under any reserved category must be in possession of valid category certificate as on the last date of the submission of online application forms. Under process certificate(s) shall not be considered/entertained. Further, the Category certificates issued after the last date shall in no case be entertained.
 21. Eligible candidates will be informed about the date and place of written examination/skill test/interview through University website.
 22. A valid e-mail ID and Mobile Number are mandatory for submitting application online and should be kept active till final selection. The university will send call letter for written test/skill test/interview to the registered e-mail ID. No correspondence will be sent by post/courier.
 23. Any addendum/corrigendum and related notifications will be published at the university website: www.cusrinagar.edu.in only. Applicants are advised to regularly visit the university website for any update/notification. No separate communication will be sent to any individual candidate.
 24. Legal disputes, if any, with Cluster University of Srinagar, the jurisdiction will be restricted within Srinagar city only.
 25. The syllabus for written test shall be notified separately and shall be made available on the official website of the university www.cusrinagar.edu.in
 26. No TA/DA will be paid for attending the written/skill test/interview.
 27. Candidates who have been awarded Bachelor's/Post Graduate / Ph.D. degree from Foreign University should enclose Equivalence Certificate issued by the Association of Indian Universities (AIU), New Delhi without which their candidature will not be considered and application form will be rejected.
 28. All the appointees including the in-service candidates shall be governed by the National Pension System/Scheme (NPS) introduced by J&K Government;

29. The service conditions including mode of appointment shall be governed in accordance with the CUS Statutes and rules of the University as are in force with amendments as may come into force from time to time, together read with provisions of J&K CSR, wherever applicable at the time of appointment.
30. In-service candidates shall route their applications through proper channel from their respective employer to Registrar, Cluster University of Srinagar which should essentially reach the office by or before the conduct of the written test.
31. The University will not be responsible for any postal delay;
