**Subject: Cancellation of withheld recommendation of candidates for the post of Works Supervisor in the Public Works (R&B) Department, advertised vide advertisement Notification No. 05 of 2020 dated 24.12.2020, under Item No. 134**

**Whereas**, the J&K Services Selection Board (JKSSB), advertised 76 posts of Works Supervisor, vide Notification No. 05 of 2020 dated 24.12.2020, under Item No. 134, and subsequently notified the Final Selection List for these posts in the Public Works (R&B) Department; and

**Whereas**, among others, the recommendations of following candidates were kept withheld on account of deficiencies as indicated against each, with the instructions to submit the requisite documents/certificates within a period of one month:

Hence, the case is being Rejected.

**Whereas**, the Board vide No. JKSSB-Scry/5/2023-01 (E-7240477) dated 11.03.2024 issued a Final Notice to these candidates to submit their requisite documents/certificates within a period of Twenty-One (21) days positively from the date of issuance of Final Notice. Whereas, none of them have produced the requisite valid document(s)/certificate(s) within the valid time period and it is implied as per the final notice that failure to produce relevant documents and clarifications would render their recommendations be treated as cancelled.

The matter related to withheld cases for the post of Work Supervisor stand discussed at length in various Board meetings viz., 285th Board meeting held on 15.10.2024, in 286th Board Meeting held on 18.10.2024, and in 342nd Board Meeting held on 18.3.2026, wherein, among other cases, the cases of aforementioned candidates were also discussed.

**Therefore**, in view of the fact that the aforementioned candidates failed to submit the requisite valid documents even after the publication of Final notice within the stipulated period, the withheld recommendations of above-mentioned candidates for the posts of Works Supervisor, Public Works (R&B) Department, advertised vide Notification No. 05 of 2020 dated 24.12.2020, under Item Nos. 134 are cancelled ab-initio.
