Kindly refer to this office letter No. JKSSB-Scry/5/2024-03(E-7642007) dated 21.01.2026, where-under the Waiting List of candidates for the posts of Supervisor, Social Welfare Department, various District Cadres, notified vide Notification No. JKSSB-Scry/3/2024-03 (E-7402474) dated 21.05.2024 pursuant to Advertisement Notification No. 02 of 2023 dated 08.12.2023, was forwarded to your department for further course of action.

Among the selectees, the recommendation of One (01) candidate namely Omeem Khattana figuring at S.no.01/ST (Waiting list) D.V S.no. 419-JMU, Roll no. 35020320, District Cadre Kupwara (Item no. 08) was kept withheld subject to clarification regarding candidate's name in category certificate . The matter was examined and the case was accordingly, placed in the Board in its 342nd meeting, which decided to release the withheld recommendation of the candidate.

The Waiting List shall also be subject to the outcome of any inquiry, involving candidate(s) figuring in this Selection List.

The document verification/scrutiny conducted by the Board is limited to the extent of establishing physical possession of the Category/Degree certificates and ascertaining genuineness/validity or otherwise of the same and recognition status of the Institution, shall be the responsibility of the Indenting Department/Appointing authority.

The Selection of the candidates has been made on the basis of Self- declaration/Certificates submitted by them and if at any stage, it comes to the light that any candidate(s) has submitted false information or has secured selection on the basis of fake documents/certificates, the selection shall be liable to cancellation at any stage and appropriate criminal proceedings against such candidate(s) may kindly be initiated.

Moreover, in terms of Government Order No.1003-JK(GAD) of 2021 dated 27.09.2021, the candidates, whose recommendations are released by the Selection Agency, shall submit their Personal Verification Roll (PVR) before the appointing authority within a period of 21 days from its release, failing which the candidate(s) shall forego their right to appointment forthwith.
