whereas, the J&K Services Selection Board, accordingly, conducted an (OMR) based written examination for the post of Re-toucher Artist on 06.02.2025. Based on the performance of the candidates in it, the Board, vide Notification No. JKSSB-COE0EXAM(UT)/6/2025-06 (7644391) dated 16.04.2025, published the Result/Score-sheet of the candidates.

whereas, after the publication of Result/Score-sheet, the candidates, falling under the consideration zone, were called for Document Verification vide Notification No. JKSSB-COE0EXAM(UT)/7/2025-03 (7646318) dated 30.04.2025, at both Jammu & Srinagar on 07.05.2025, followed by supplementary DV on 18.06.2025.


