Applications are invited in the prescribed format from eligible doctors (Non-PSC) who are domicile of the Union Territory of Jammu & Kashmir for engagement as Junior Residents on a tenure basis in various disciplines of Government Medical College, Rajouri. The engagement shall initially be for a period of six (06) months and may be extended up to a maximum period of one (01) year, subject to satisfactory performance.

1. HOW TO APPLY

- Interested and eligible candidates shall submit the duly filled application form (annexed with this notification) in the office of the undersigned on or before 15.06.2026 up to 04:00 PM at Mehra Campus, GMC Rajouri.
- The application form, complete in all respects, must be accompanied by a non-refundable application fee of Rs. 500/- (Rupees Five Hundred Only) in the form of a Bank Draft pledged to "Principal, GMC Rajouri" or deposited in the following account:

2. MODE OF SELECTION

Selection of candidates shall be made strictly on the basis of merit secured in the Written Examination/Screening Test. The date, time and venue of the Written Examination/Screening Test shall be notified separately through the official website of Government Medical College, Rajouri.

8. FMGE Screening Test Certificate (where applicable).
9. Registration Certificate issued by the Jammu & Kashmir Medical Council/National Medical Commission, as applicable.
10. Certificates relating to Distinctions, Honours, Medals, National Scholarships, Academic Merit or any other academic achievements, if any.

4. TERMS AND CONDITIONS

1. Candidates who have already completed Junior Residency are not eligible.
2. The selected candidates shall be required to submit an affidavit duly attested by a Judicial Magistrate at the time of joining, stating that they shall not leave the residency programme midway and shall serve a minimum tenure of six (06) months.
3. The appointees shall be paid remuneration/salary as admissible under the relevant rules in force from time to time.
4. Any appointed/serving Junior Resident intending to resign from service shall be required to give one month's prior notice duly forwarded by the concerned Head of Department. In the event of failure to provide the requisite notice, the Junior Resident shall be liable to deposit one month's salary with the institution.
5. No experience certificate shall be issued to any Junior Resident who has rendered service for a period of less than six (06) months.
6. No TA/DA shall be admissible for appearing in the Written Examination/Screening Test or for joining the institution.
7. The appointees shall not be entitled to private practice or undertake any part-time or full-time employment elsewhere during the tenure of their engagement. They shall be required to work on a full-time basis.
8. The Competent Authority reserves the right to amend, modify, withdraw, cancel or alter any condition of this advertisement, either wholly or partly, at any stage without assigning any reason and without prior notice.
9. Mere submission of an application form and supporting documents shall not confer any right upon a candidate for consideration or selection. The candidature of all applicants shall remain provisional and may be cancelled at any stage if found ineligible or if any information furnished by the candidate is found to be incorrect.
10. The Written Examination/Screening Test shall be conducted against the posts that are vacant or likely to fall vacant. However, the institution reserves the right to increase, decrease, alter or withdraw the number of vacancies or to decide not to fill any or all vacancies at any stage of the selection process without issuing any further notice.



2. In the event of a tie in merit between two or more candidates in the Written Examination/Screening Test, preference shall be given to the candidate securing higher aggregate percentage marks in MBBS.
