It is hereby notified for information of all the concerned that the following schedule has been fixed for submission of Permission cum Examination Forms **through online/offline mode** for Higher Secondary Part-I (Class 11<sup>th</sup>) Annual (Private)/Bi-annual 2026 examinations for Kashmir and Jammu Division (both winter and summer zone areas) of UT's of J&K and Ladakh.

- No candidates with vocational subjects, as one of the elective subject shall eligible to appear under Private capacity except those who have already passed the practical/s of the corresponding vocational subject.
- No practical fee shall be charged from the candidates who have already qualified practical/s in their re-appear subject(s). However, fee for seeking permission for conduct of internal Practical/s by the concerned Schools be realized on prescribed fee. In case of external practical/s a fee of Rs.100 per subject shall be charged, wherever applicable.
- The candidates who have passed their class 10<sup>th</sup> examination in the Annual (Private)/Bi-Annual 2025 session shall be eligible to appear in the ensuing Annual Private/Bi-Annual 2026 examination under the fresh private category.
- Registration Renewal/ subject change fee, wherever applicable will be accepted in addition to examination fee.
- The question papers for the examinations will be set from new syllabi as is presently in vogue.

## Instructions/ guidelines:

After completion of online service, all the institutions will generate the checklist from their respective school accounts and submit the same to the concerned examination Unit/ Sub/ Branch offices, duly signed and stamped by the Head of the institution, within 2 days positively.

- i. For any query, the students / Heads of the affiliated academic institutions are informed to approach the concerned Sub/ Branch offices of the BOSE. - ii. The detailed instructions / FAQ's shall be made available on the official website of JK BOSE. The stakeholders in their own interest are advised to go through instructions / FAQ's before filling the examination forms.
- iii. **Notification regarding conduct of practical examination wherever applicable (internal / external) shall be issued separately in due course of time.**
- iv. The specially-abled candidates with a benchmark disability of 40% or more are exempted from paying examination/R.R renewal fee, however, they shall take a printout of the examination form submitted online and get it attested by the concerned academic institutions and submit the same in the jurisdictional Sub / Branch office/s of JKBOSE along with the copy of disability certificate from the district Medical Board/ competent authority.
