Whereas, the Jammu and Kashmir Services Selection Board (JKSSB) advertised the aforesaid 2 posts of Career Counselling Officer, Labour & Employment Department among various posts vide Advertisement Notification No. 04 of 2020 dated 16-12-2020 and the cut-off date, i.e., the last date for applying for the aforementioned posts and for determining the

eligibility/academic qualification and validity of category certificates and other such documents of the candidates which may be required as per Indent was **31.01.2021**; and

Whereas, in terms of the notified selection criteria, the recruitment against these posts was to be made in the following manner:

"Marks obtained in the written test out of maximum marks shall be proportionately converted into points =80 Viva voice =20 Total=100"

Whereas, the JKSSB conducted the OMR based Written examination for the said posts on 18.03.2024 and the Final Answer Key was notified. This was followed by the Document Verification-cum-Interview/Viva-Voice of the candidates shortlisted vide Notice No. JKSSB-ADM/23/2024-03(7418850) dated 08.10.2025; and

Whereas, for the purpose of conducting the Document Verification-cum-Interview/Viva Voce for the post of Career Counselling Officer in the Labour & Employment Department, advertised under Item No. 074 vide Notification No. 04 of 2020 dated 16.12.2020, an Interview Panel was constituted vide Office Order No. 304-SSB of 2025 dated 09.10.2025.; and

Whereas, the Document Verification-Interview/Viva Voice for the instant post was held at **JKSSB Office, ZamZam complex Srinagar on 15.10.2025 from 11.00 AM**; and

Whereas, the Selection Committee for preparing the Selection List to the aforementioned posts was constituted vide Office Order No. 333 of 2025 dated 28.10.2025; and

Whereas, 11 candidates, falling in the consideration zone, were shortlisted for the Document Verification-cum-Interview/Viva Voice and 10 candidates participated in it; and

Whereas, the Provisional Selection List, prepared by the concerned Selection Committee in accordance with the extant rules and on the basis of the merit secured by the candidates in the Written Test and Interview/Viva Voce, was placed before the Board in its 348th Meeting held on 30.04.2026, and the same, after due deliberation, was approved for notification.

Now, therefore:

1. On the basis of the performance in the Interview/Viva Voice, the weight-age accorded to the marks secured in the written test, the merit of the candidates who appeared in the interview is enclosed as **Annexure-A** to this Notification.

2. Consequent upon the above, the Provisional Selection Lists for the of Career Counselling Officer Item No. 074 vide Notification No. 04 of 2020 dated 16.12.2020, is hereby notified as per **Annexure-B** to this Notification.
3. The Provisional Selection Lists shall be subject to the outcome of writ petition(s)/OAs, if any, pending in any Court of Law of the competent jurisdiction.
4. The provisional Selection Lists shall also be subject to the outcome of pending inquiry, if any, involving candidate(s), figuring in this Selection List.
5. These Lists are provisional only, and mere figuring in the aforementioned lists shall not confer any right on the candidates for final selection.
