**Terms and Condition:-**

1. The candidate must be a resident of UT of Jammu and Kashmir.
2. The hiring is purely on contractual basis for a period of one year which will be renewable on year to year basis subject to good performance and conduct or till the continuation of centrally sponsored scheme, whichever is earlier.
3. The appointing authority shall have the right to terminate hiring without assigning any reason.
4. The candidate shall have to give one month advance notice before leaving the job. The contractual hiring shall be terminated any time by giving one month advance or one month advance remuneration in lieu of notice.
5. The contractual hiring shall not confer any right on the candidate to claim extension or benefits or regularization.
6. The consolidation honorarium per month is inclusive of all allowances and monetary benefits to be conveyed by NDDTC New Delhi.
7. The entitlement of leave travel etc. shall be governed by the rules in vogue.

8. The candidates shall have to report within seven days from the date of issuance of selection list along with the requisite original documents for further verification process following which his/her appointment shall automatically be treated as cancelled.
9. The candidate shall have to execute a contract agreement with the Principal GMC Jammu/nodal Officer ATF that he/she shall not claim for any regular appointment/extension in the department.
10. The hiring shall be governed by other terms and conditions as or not specifically mentioned herein but are made applicable in case of such appointments at any time by the contracting authority.
11. The date of screening test, if any and its venue shall be notified on website of GMC Jammu.

13. No separate interview call letter shall be issued individually.
14. In case of Interview, the candidates in the ratio 1:5 shall be called for interview on the basis of basic merit as per selection criteria.

The applicant shall submit the duly filled application form in the prescribed format along with the following self attested documents:


- a) Relevant essential qualification certificate including marks cards and degree/diploma.
- b) CGPA to percentage calculation documents must be attached, if are final marks are in grades.
- c) Domicile certificate.
- d) Relevant experience certificate from competent authority.
- e) Matriculation certificate/Date of birth certificate.
- f) One passport size photograph attested by Gazetted Officer to be affixed on the application form and one spare photograph is to be submitted along with the form.

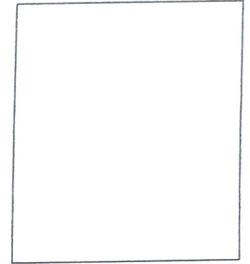
