Whereas, this office vide Advertisement Notice **No. 07 GMCA of 2026, Dated:- 02.04.2026** read with notification **No. 06 GMCA of 2026, Dated:- 28.04.2026** invited applications from the eligible candidates possessing requisite qualification for filling up tenure posts of Senior Resident (in-service/not in-service doctors) in the discipline of Pathology, Government Medical College, Anantnag as per Criteria/Policy Guidelines for eligibility/selection of the tenured positions of Senior Residents/Tutors issued vide Government Order **No. 383-JK (HME) of 2024, Dated:- 20.06.2024**; and

Whereas, in response to the aforesaid Advertisement Notice, this office received various application forms in the aforementioned discipline; and

Whereas, on scrutiny of application forms, it was found that the number of applications received were more than the number of available posts and the written test was therefore conducted on **06.06.2026** at Main Campus Dialgam as per Govt. Order **No. 382-JK (HME) of 2024, Dated: - 20.06.2024**;

Whereas, the merit list of the candidates who appeared in the said written test was published vide this office notification dated 12.06.2026; and

Whereas, one **(01)** vacancy was available in the discipline of Pathology and accordingly one **(01)** candidate was selected vide this office Notification **No. 10 GMCA of 2026, Dated: 29.06.2026**;

Whereas, one **(01)** more vacancy occurred in the discipline of Pathology consequent upon relieving of Dr Zarkah Nabi;

3. Affidavit (attested by the 1<sup>st</sup> Class Judicial Magistrate) to the effect that: -
  - e) He/she is the domicile of Union Territory of J&K and is in possession of all requisite documents/certificates.
  - f) He/she has not done senior residency/demonstratorship earlier within or outside J&K Union Territory. (only for those candidates who are applying afresh).
  - g) He/she has done \_\_\_\_\_ months of senior residency/demonstratorship in the \_\_\_\_\_ institution/medical college. (only for those candidates who have already done 30 or less than 30 months of senior residency/demonstratorship)
  - h) The information submitted in the application form is true and correct and nothing has been concealed therein.

However, if the selected candidate fails to report to the Office of Principal, Government Medical College Anantnag within the stipulated time, his/her selection in the concerned discipline shall forfeit without any further notice.

**Note:** Mere issuance of this notification does not entitle the selected candidate to claim appointment/engagement.


