

It is notified for the information of all the concerned that:

1. The candidates shown in **Annexure-"A"** to this Notification have been shortlisted for interview based on the merit secured by them in the OMR-based written examination held on **27.06.2026 at Jammu & Srinagar** centres, for the post of Driver Grade-II (Now Transport Assistant-II) in the District Judiciary of UT of J&K, pursuant to Advertisement Notification No. 03 of 2025/Psy dated 26.06.2025.
2. The interview of the shortlisted candidates will held on **18.07.2026 (Saturday)** at the **High Court Complex, Janipur, Jammu** for Jammu based candidates, and on **20.07.2026 (Monday)** at the **High Court Complex, Srinagar** for Kashmir Based candidates. The date and venue of the interview is shown against each candidate at **Annexure-A**.
3. **The reporting time for the interview shall be 9:00 AM.**
4. The candidates shall have to bring proof of identity with them at the time of the interview, like Aadhar Card, PAN card, Driving license, Passport etc.
5. The candidates shall have to produce all original certificates/Documents/testimonials Such as Marks Sheet/Diploma of prescribed qualification, Domicile certificate, Driving License, Category certificate, any other relevant document before the interview committee at the time of their interview, along with photocopies of the same. Any candidate who fails to produce his/her original certificates/testimonials may forfeit his/her candidature.
6. Mere figuring of name in the shortlist shall not entitle a candidate to appear in the interview, which shall be subject to the scrutiny of all testimonials of the shortlisted candidates.
7. No individual interview call letters shall be issued to the shortlisted candidates.
8. In the event of any deficiency found at the time of the interview concerning the eligibility of any candidate, such candidate may not be allowed to appear in the interview.


