

- i. The promotions shall take notional effect from the dates indicated against the officials, while the monetary benefits shall be admissible only from the date of issuance of this order.
- ii. The promotion of official at serial No. 1 is subject to verification of the validity of the qualification certificate and confirmation of its equivalence to a regular Bachelor's degree by the University of Kashmir.

- iii. The qualification certificates of the promotees shall be verified from the concerned Universities/Boards, if not verified yet. Pending verification, salary against the post of Junior Assistant shall not be released. In case of adverse verification, the promotion to such official shall deem to have been cancelled and he/she shall be liable for action under applicable rules.
- iv. The posting order of the promotees shall be issued separately, till then they shall perform their duties at the present place of posting.


