The engagement shall be governed by the following terms and conditions:

- The engagement shall purely be temporary, time bound, non-regular on academic arrangement basis and the contractual appointee shall not be entitled to any claim of absorption/ regular appointment in the University/continuation of service beyond the time stipulated herein.
- The engagement shall initially for one semester commencing and extendable for one more (next) semester depending upon satisfactory work and conduct performance of the appointee as well as availability of the funds.
- The appointee before joining shall have to execute an legal agreement with the Dean, Faculty of Agriculture, SKUAST-J, Chatha (a constituent of the University) on the prescribed format appended herewith duly attested by the First Class Magistrate.
- The engagement of appointee shall be terminable before the expiry of the specified period with one month's salary in lieu of notice by the appointing authority or the engaged teacher, as the case may be.
- The work and conduct of the appointee will be monitored, if found unsatisfactory, the service will be terminated without any notice.
- The appointee shall have to report within 21 days from the issuance of this order to Dean, Faculty of Agriculture, SKUAST-Jammu failing which the appointment shall be treated as cancelled automatically.
