Pursuant to Notification No. 138-BOPEE of 2026 Dated 06-08-2026, the Board notified 2nd round of online counselling schedule for submission of online preferences/choices w. e. f 07-08-2026 (11:30 A.M. onwards) to 09-08-2026 (Mid-night) for filling up of seats of B.Ed. Course-2026. The list of candidates provisionally Allotted seats in Government/Private Colleges/Institutions of UT of J&K, is hereby notified as per Annexure-A to this notification, which shall be available on the official website of the Board viz. www.jkbopee.gov.in only.

Any candidate desirous of making any representation against the position assigned to him/her in the Provisional Selection List may, if so chooses, do so up to **18-08-2026 (4:00 p.m.)** with documentary evidence in support of his/her claim and send the representation/documents to helpdeskjakbopee@gmail.com . If a genuine representation is received, a separate notice/notification will be issued for the issuance of the Revised Selection List.

If no further notice/notification is issued, Annexure A will be deemed final, and provisionally selected candidates should report to their assigned colleges/institutions w.e.f. **19-08-2026 (11:00 a.m. onwards) to 21-08-2026 (up to 05:00 p.m.)** along with their relevant certificates in original.

The Provisionally Selected candidates are advised to generate the Provisional Allotment Letter through JKBOPEE portal using their own credentials. Thereafter they have to report to their respective allotted Colleges/Institutions for completion of admission formalities up to **21-08-2026 till 05.00 p.m.** along with the following documents in original:

- i) Qualifying Marks Certificate (10+2+3);
- ii) Domicile Certificate of UT of J&K / Ladakh (for candidates belonging to UT of Ladakh, ST certificate issued by Competent Authority of UT of Ladakh shall be treated as Domicile Certificate);
- iii) Category Certificate, if any;
- iv) Date of Birth (DOB) Certificate and
- v) Any other certificate required by the College in accordance with the rules.

The eligibility conditions for admission to this course shall be as mentioned in the Notification No. 042-BOPEE of 2026 dated 11-03-2026 /e-Information Brochure available on the J&K BOPEE website.

It is, hereby, implored upon the management of all the concerned Colleges/ Institutions to ensure the veracity of documents, particularly the Category Certificates wherever the admission is to be granted in lieu of a Reserved Category.

The cut-off date for validity of the Category Certificate shall be **26-03-2026**, i.e., the last date fixed by the Board for filling up of online application form for the B.Ed. Course-2026.

In order to complete the admission process within the prescribed cut-off date **21-08-2026 till 5:00 p.m.**, the concerned Colleges/Institutions shall keep their admission counters open even on holidays/off days to facilitate the candidates to complete their admission process well in time. **However, the candidates in their own interest shall avoid waiting for last day to complete admission formalities through online admission portal since delay has the potential of causing hardships to the candidates only.**

The Heads of the concerned Colleges/Institutions are advised to ensure that all the admissions shall be made through JKBOPEE Portal within the stipulated time fixed by the Board.

Note:

- I. The admission of the candidates is purely provisional and shall be cancelled in case any information furnished by any candidate proves to be false/fabricated, and action as warranted under rules shall be initiated against such candidates.
- II. The allotment of seats (discipline/institution) in respect of reserved category candidates have been made in accordance to the provisions of **S.O. 176 of 2024 dated 15-03-2024 read with S.O 305 dated 21-05-2024.**
- III. **The Concerned Colleges/Institutions shall ensure that, in case a person with disability, is selected in open merit or some reserved category, the college/ institution concerned shall refer such case(s) to the Medical College concerned for constitution of special Medical Board to assess such candidates and make recommendations based on which colleges shall take further necessary action. In case, any such candidate does not fulfil the bench marks of disability, he/she shall not be admitted to the course/ college and the matter shall be reported to the BOPEE.**
- IV. The candidate, who has been allotted a seat, has to download the **Provisional Allotment Letter** and physically report with original documents at the allotted Institution for completing admission formalities within the time period as notified by the Board. The institution shall issue the joining certificate to such candidates. The candidates are advised to verify their joining status on the portal.
- V. If a seat has been allotted to a candidate and he/she does not join the Institution within the stipulated time period as notified by the Board, i.e. **21-08-2026 (5:00 p.m.)**, his/her allotted seat shall be treated as cancelled and his/her claim on the allotted seat shall cease.
- VI. If a candidate after getting admission in an Institution intends to cancel his/her admission from the Institution, he/she can do so by submitting an admission cancellation application by or before the last date fixed for reporting/joining by the BOPEE i.e **21-08-2026 (5:00 p.m.)**. The institutions shall upload the admission cancellation application on admission portal and shall cancel his/her admission. The candidate can verify his/her admission cancellation status on the portal. The allotted seat will be treated as cancelled.
- VII. If any candidate fails to join the allotted College/Institution within the stipulated time period as notified by the Board, his/her claim on the seat shall cease.

- VIII. **A candidate who has been allotted a particular institution and discipline in Round-2 of counselling and has joined the allotted seat or failed to join, or cancelled his/her admission after joining, shall not be permitted to fill or opt for same institution in the third round. However, the candidate may opt for other institutions in the third round, subject to availability of seat(s).**
- IX. **No fee shall be charged for cancellation of seat from the candidate by the Institution during any round of Counselling.**
- X. For fee/documents required in the College/Institution, the provisionally selected candidates are advised to contact concerned College / Institution before the last date of admission.
- XI. The Principals of the concerned Colleges / Institutions are advised to download the copy of this Notification from the website of the Board viz. www.jkbopee.gov.in for reference and record.
- XII. **The Nodal officers of the institutions/colleges must verify the documents uploaded on the JKBOPEE online admission portal as well as others required documents mandatory for admission before allowing the candidate to join.**
- XIII. **All the admissions for the course shall be made through JKBOPEE online admission portal only. The admissions made through offline mode shall not be accepted.**
- XIV. The other terms and condition shall remain the same as notified in the e. Information Brochure/Notifications & Notices issued by the Board in this regard from time to time.

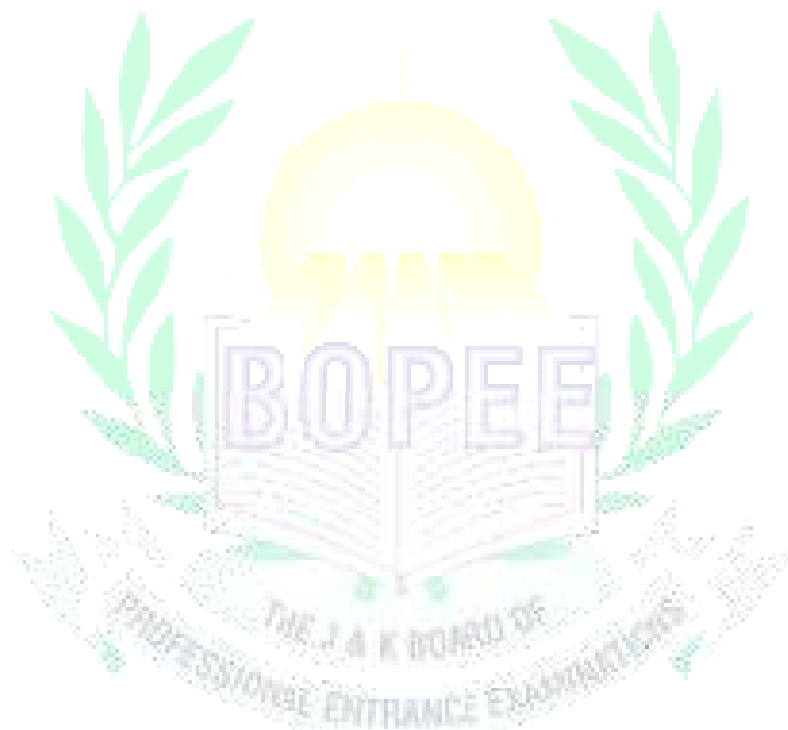
