Consequent upon the issuance of Notification No. 139-BOPEE of 2026 Dated: 06.08.2026, the candidates belonging to NRI category have uploaded their documents upto 10th of August, 2026. As a pre-requisite these documents were checked and verified on 11th of August, 2026 by a Committee constituted for the purpose.

After aforesaid verification of documents submitted by the candidates, it has been found that documents of only Fifteen (15) candidates out of the total of sixty two (62) are complete in all aspects and documents of forty seven (47) candidates have been found deficient or have been rejected as mentioned against each in **Annexure-A** to this Notification.
