Terms of Reference:

- i) To examine the existing service conditions, cadre structures, recruitment rules and promotional avenues applicable to employees appointed under the Hon'ble Prime Minister's Package for Kashmiri Migrants and employees of J&K Relief Organization (DMRRR).
- ii) To identify and suggest measures to address the issues leading to stagnation or other impediments affecting the career progression of these employees.
- iii) To evaluate the financial, administrative and legal implications of the proposed measures.
- iv) To suggest amendments in the relevant rules, wherever required, for effective implementation of the recommendations.

The Committee shall submit its report along-with recommendations to the Government within a period of one month from the date of issuance of this order.
