Islamic University of Science and Technology (IUST), Awantipora (J&K)

1. ABOUT THE UNIVERSITY

Islamic University of Science and Technology (IUST), Awantipora, established under IUST Act No. XVIII of 2005, is a premier State University committed to excellence in technical and professional education in the Union Territory of Jammu & Kashmir. The University offers programmes in Engineering, Management, Sciences, Humanities, and Islamic Studies, with a vision to foster research-driven, innovation-led education aligned with national and global standards. IUST is recognised by the University Grants Commission (UGC) under Sections 2(f) and 12(B) of the UGC Act, 1956, AICTE, and is accredited by the National Assessment and Accreditation Council (NAAC).

2. THE POSITION

The Selection Committee, constituted vide Order No. 04-LGS of 2026 dated 28-02-2026 read with Order No. 32-LGS of 2026 dated 29.08.2026, issued by the Hon'ble Lieutenant Governor's Secretariat, Lok Bhavan, Srinagar as per the provisions of the J&K Islamic University of Science and Technology Act, 2005, **UGC Regulations on Minimum Qualifications for Appointment of Teachers and Other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education, 2018** (hereinafter referred to as "**UGC Regulations, 2018**"), and applicable statutory provisions, invites nominations and applications from distinguished academics for the position of **Vice Chancellor** of the University.

3. ROLE AND RESPONSIBILITIES

The Vice Chancellor is the **principal academic and executive head** of the University and shall exercise all powers as prescribed under the University Act, Statutes, and Ordinances.

The Vice Chancellor shall be responsible for:

- (a) Providing academic vision, strategic direction, and dynamic leadership to the University.



- (b)Overseeing all academic, administrative, financial, and developmental activities of the University.
- (c)Ensuring implementation of national education policies, including the National Education Policy (NEP) 2020.
- (d)Fostering a culture of research, innovation, entrepreneurship, and interdisciplinary collaboration.
- (e)Enhancing the University's national and international standing through academic partnerships, rankings, and accreditations.
- (f) Promoting equity, inclusion, and access in higher education, with particular focus on the socio-educational upliftment of the region.
- (g)Building industry-academia linkages and strengthening the University's engagement with society.
- (h)Ensuring financial sustainability, resource mobilization, and efficient fund utilization.

4. ELIGIBILITY CRITERIA

The candidate shall fulfil the eligibility requirements prescribed under **Regulation 7.3 of the UGC (Minimum Qualifications for Appointment of Teachers and Other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education) Regulations, 2018**, as applicable, read with the **IUST Act and the University Statutes**, and shall possess the following qualifications and experience:

- a) The candidate shall be a **distinguished academician/eminent scholar**, possessing a **Ph.D. degree and a consistently outstanding academic record**, with demonstrated academic and institutional leadership.
- b) The candidate shall have a minimum of **ten (10) years of experience as Professor in a University or ten (10) years of experience in a reputed research and/or academic administrative organisation**, with demonstrable evidence of having provided academic leadership.
- c) The candidate shall possess **high academic standing, integrity, moral stature and institutional commitment**, and shall have demonstrated the ability to provide effective academic and administrative leadership to a University.

5. AGE LIMIT

The candidate shall not be more than **65 (sixty-five) years** of age as on the last date of receipt of applications as notified in this advertisement. During the tenure of office, the Vice Chancellor shall not continue beyond the age of 70 (seventy) years.



6. TERM OF OFFICE

The Vice Chancellor shall hold office for a term of **three (03) years** extendable up to **five (05) years** from the date of assumption of charge, or until attaining the age of **seventy (70) years**, whichever is earlier.

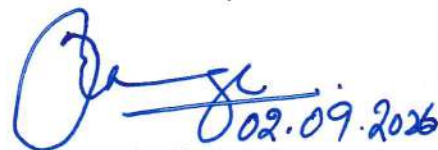
