TERMS & CONDITIONS

- 1) The candidate selected as Senior Resident shall be engaged initially for a period of one year which is extendable up to maximum of three years (Govt. Order No. 383-JK(HME) of 2024, Dated: 20.06.2024). However, extension on year-to-year basis shall be granted subject to satisfactory performance of the candidates, to be certified by the concerned HOD after completion of each year of their engagement.
- 2) As per Government Order No. 383-JK(HME) of 2024, Dated: 20.06.2024, the eligibility criteria have been fixed as per Teachers Eligibility Qualification in Medical Institution regulations, 2025 issued vide notification Dated: 30.06.2025.

- 3) The selection of the candidates shall be made on the basis of the performance in MCQ based written test only as prescribed vide Government Order No. 383-JK(HME) of 2024, Dated: 20.06.2024.
- 4) Any candidate having already undergone senior residency shall not be eligible to apply against the notified positions. However, if he/she has done senior residency up to 30 months or less than 30 months, he/she can apply to undergo the remaining senior residency period so as to complete three years term.
- 5) The candidates shall have to submit an Affidavit duly attested by the Judicial Magistrate to the effect that:-
 - a) He/she is the domicile of Union Territory of J&K and is in possession of all requisite documents/certificates.
 - b) He/she has not done senior residency earlier within or outside J&K Union Territory (only for those candidates who are applying afresh).
 - c) He/she has done 30 or less than 30 months of senior residency in the institution/medical college (only for those candidates who have already done 30 or less than 30 months of senior residency).
 - d) The information submitted in the application form is true and correct and nothing has been concealed therein.
- 6) Conditions for Non-In-Service/In-Service Candidates:-
 - a) For (Non-In-Service) Academic Arrangement Basis candidates:
 - Those candidates who are not in-service shall be engaged under S.O 364 of 2020, Dated: 27.11.2020 (Academic Arrangement Basis).
 - Non-In-Service candidates shall be paid stipend in accordance with S.O. 364 of 2020 Dated: 27.11.2020.
 - Non-In-Service candidates who are already undergoing senior residency and have not exceeded 30 months of tenure and are interested to apply in this Institution shall produce a No Objection Certificate/Relieving Order from the Institute they are serving.
 - b) For In-Service candidates:-
 - The application form of the In-Service eligible candidates shall be entertained only after fulfillment of all pre-requisites, in accordance with relevant rules, as envisaged in the J&K Civil Service Rules 1979 and production of NOC from the parent department, as envisaged in the Circular No. 03-HME of 2019, Dated: 27.05.2019 and other guidelines issued by Administrative Department from time to time.
 - The in-service doctor shall be paid salary as per their LPC.
 - In-Service Candidates already undergoing/undergone senior residency elsewhere are debarred from applying.
- 7) The application form(s) should be accompanied with the following self-attested copies of the documents:
 - a) MBBS Degree certificate from a recognized University/Institution.
 - b) Internship completion certificate.
 - c) MD/MS/DNB qualification/degree certificate of the respective specialty.
 - d) NMC/J&K Medical Council Registration Certificate of MBBS and MD/MS/DNB.
 - e) All Mark sheets MBBS/MD/MS/DNB.
 - f) Date of Birth Certificate.

- g) Domicile Certificate.
 - h) No Objection Certificate (for In-service candidates only).
 - i) Screening Test Pass Certificate (in case of FMG's).
 - j) Experience certificate (only for those candidates who are already undergoing senior residency and have not completed 03 years of tenure as senior resident).
 - k) Affidavit.
- 8) Application form(s) incomplete in any respect or not appended with relevant documents/certificates shall be rejected without further notice.
- 9) In the event of applicants possessing the requisite postgraduate qualification (MBBS with MD/DNB) in the Department of Forensic Medicine are not available, candidates holding an MBBS Degree may be considered for appointment as Tutors against the available vacancies in the aforesaid department. Such engagement of non-postgraduate candidate shall be strictly temporary for a period of 06 months and extendable for a maximum period of one (01) year only. Under no circumstances shall the appointment be extended beyond one year and it shall automatically terminate upon the joining of a candidate possessing the prescribed postgraduate qualification.
- 10) The Competent Authority reserves the right of any amendment, cancellation and modification to this advertisement as a whole or in part without assigning any reason.
- 11) Candidates may note that their candidature will remain provisional till the genuineness of their character & antecedents/documents relating to educational qualification are verified by the appointing authority.
- 12) Separate application along with requisite fee is to be filed for each post applied.
- 13) In case any declaration by the candidates is found to be false or if the candidate has willfully suppressed any material/information relevant to his/her engagement, his/her selection will be cancelled ab-initio and action as warranted under rules shall be initiated against the erring candidates.
- 14) The selected candidates shall have to execute an agreement as mentioned in S.O-364 of 2020, Dated: 27.11.2020 and that he/she will not leave the Department before the completion of tenure (six months), however abandoning/terminating of the engagement in the specialty will require one-month prior notice on either side failing which the salary shall not be paid for one month to the incumbent and shall be released on completion of sanctioned term.
- 15) The maximum age for eligibility to apply shall be 45 years, however for the departments of Community Medicine and Forensic Medicine, the upper age limit shall be 50 years as on cutoff date of advertisement for both in-service and non-PSC candidates.
- 16) There shall be a waiting list which shall remain in force for a period of 03 months from the date of issue of the selection list.
- 17) In case of a tie in merit secured by two or more candidates in the written test, the candidate(s) with earlier date of birth shall be given preference.
- 18) No selected candidate who joins the institution as Senior Resident/Demonstrator/Tutor shall be given experience certificate, if he/she fails to serve on such post/position for at least six months.

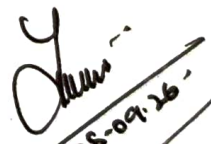
